- Hospital: Neil Springer Labette Health had a Code black bomb threat in Dec. Davita dialysis and other clinics also received this threat. It is an email that has been going around since 2018. It is a scam. They used the real event as a drill and treated it like a real threat. They also had a power outage earlier this month and an electrical fire. These incidents were also used as a real event and drill. Girard hospital Nick groether reported water issues within the city that have caused issues with clean water in the hospital. There have been several water main breaks. Ascension Via Christi Hospital Pittsburg reported Bus accident that gave them several learnings and was used as a real event drill. They also reported they were bought out by Mercy and will plan to switch to Mercy by July 1 at the start of the new fiscal year. Allen Co- no updates from Tina Spencer, State hospital in Independence Marlys Shomber -Jones, has new emergency exits that light up and are wireless so they can update as needed. They also reported that they have an outreach team that will come out and instruct on special populations.

- EMS: Shane -Newton County, Fredonia Regional Medical Center, reported to be busy, They had a Bus wreck 1 mo ago with wrestling kids with minimal injuries. They also have had a lot of issues with Bed bugs, They did get a new truck Accidents have dropped off some but are still high for the area.

- Emergency Management: Most are at a conference today in Wichita, Lebetter LEPC hired a consultant to do LEPC meetings Fred Renne. Montgomery County has a new company that moved in Bartlett, This will increase traffic significantly with 400-500 semis a day coming in. They also have 1,000 gallons of Hexane gas on site. They have worked well with EM and fire to mitigate risks and installed a new water line. They will also have a rail line built. Other processing plants have looked into moving into this area will have a great impact on the economy and attracting other businesses. Osha has oversight of the waste component. Jaime asked if we could get a presenter from that company to come to the HCC meeting.

Staff are also being trained on car seat safety and plan to do some events to check car seats. Debrah Anthony Crawford County also does car seat safety.
